NOTICE FOR ALL NEW WATER TAP INSTALLATIONS

PER: NEW EPA REGULATIONS :

PLEASE **DO NOT REMOVE THE LOCK** FROM YOUR METER BOX UNTIL IT HAS BEEN INSPECTED BY A MARCO EMPLOYEE. PLEASE CALL AT LEAST ONE DAY BEFORE NEEDING INSPECTION.

LEAVE WATER / SERVICE LINE UNCOVERED FROM YOUR METER TO YOUR HOUSE

ONCE YOU INSTALL AND HOOK INTO THE METER BOX / CUSTOMER CUT OFF VALVE BOX. WATER WILL NOT BE TURNED ON UNTIL THE COMPLETE LINE HAS BEEN INSPECTED.

YOUR METER BOX WILL BE **LOCKED** WHEN TAP IS INSTALLED UNTIL YOUR WATER / SERVICE LINE HAS BEEN **VISUALLY INSPECTED** BY MARCO WATER COMPANY. ONCE THE INSPECTION IS COMPLETE, WATER WILL THEN BE AVAILABLE TO YOU.

YOU MUST NOTIFY US WHEN YOUR LINES HAVE BEEN INSTALLED AND YOU ARE READY FOR IT TO BE INSPECTED. INSPECTIONS WILL NOT BE PERFORMED AFTER BUSINESS HOURS, WEEKENDS OR HOLIDAYS. **SAME DAY IS NOT PROMISED.*

IF WE FIND THAT THE METER BOX HAS BEEN BROKEN INTO OR TAMPERED WITH PRIOR TO MARCO INSPECTION, THERE WILL BE ADDITIONAL CHARGES AT A MINIMUM OF \$150.00 PLUS ANY SERVICE CHARGES AND DAMAGES.
